<ul style="list-style-type: none"> I agree to refrain from removing any safety devices installed by the manufacturer(s) or the Club on the tools.
<ul style="list-style-type: none"> I promise not to permit any unauthorized person to operate the tools. I will not leave the building unattended and unlocked during any period of use by me.
<ul style="list-style-type: none"> I agree to not use the equipment to produce business-related projects.
<ul style="list-style-type: none"> I agree to clean up the area after using the equipment.
<ul style="list-style-type: none"> I acknowledge that personal injury including death can result whether or not tools are used properly and hereby assume this known risk. I also am aware that medical attention is not available at or in the vicinity of the Workshop.
<ul style="list-style-type: none"> I agree on behalf of myself and my heirs, successors and assigns, to hold harmless and indemnify the Club, its Board, Trustees, Members, agents, servants, employees and independent contractors from and against any and all claims, loss, damages, liability or expense including, without limitation, attorneys fees and court costs and expense, arising out of or in any way related to any act or neglect by myself when under a duty to act in the use by myself of the Workshop and or tools.
